S.P.C.F.P.D. Mission Statement:

The Mission of the Southern Park County Fire Protection District is to provide fire protection and emergency rescue operations within its 240 square mile district boundaries; encourage fire and human caused disaster prevention through community education; ensure the existence of a properly trained team of primarily volunteer firefighters who are able to, and motivated to, respond professionally and work safely; acquire and maintain the necessary equipment; and provide mutual aid to neighboring fire and emergency services departments, as requested.

Summary:

1. Equipment status

- 1. Rescue 9-1 radio installed; working on electronic control unit. Watts Up is helping troubleshoot the V-Mux system remotely at no cost to us.
- 2. Engine 9-3 will work if needed. Worn alternator belt is a concern. As soon as Engine 9-1 is back in service, we will attempt to repair the belt in-house. For now, the truck is operational. Neighboring district chiefs are aware of our situation.
- 3. Engine 9-1 is going to Fire Truck Solutions in Denver on Tuesday, 11/4. Should be back in service by the board meeting on the 6th.
- 4. Tender 9-3 was serviced and driven by Jim Yoder.
- 5. Med 9-1 repair and safety inspection is complete.
- 6. Squad 9-2 needs injector / glow plug repair, but is still running and in service. Replacement build begins in 2026.
- 7. Med 9-3 is quartered at station 2 due to updated response matrix. Med 9-1 is at station 1.
- 8. We may have a buyer for decommissioned Squad 9-2 and Squad 9-3. Offer is at \$3.5k currently for both vehicles.
- 9. Command 9-1 has new brakes and rotors. Install performed by 901.
- 10. Command 9-2 should be retrieved and back in service by the board meeting on the 6th. There were some extra costs on the installation of the new motor; these were verbally approved by the Chief and common sense repair.

2. CIP Projects

No progress to report since last meeting. Purge of extra and old equipment (clutter in the bay) will begin in earnest in November.
